Secondary students are exempt from these fees. Concession fees/exemptions will be applicable to eligible students. This Training is subsidised by the Government of Western Australia - Department of Training and Workforce Development.

<sup>2</sup> KFC RTO is a *Smart and Skilled* Provider. This training is subsidised by the NSW Government. Concession fees/exemptions will be applicable to eligible students. **Smart and Skilled** training will be fee free for NSW trainees and school based trainees who commence their training on or after 1 January 2020 through the Smart and Skilled Fee Free Traineeship Initiative. Under this arrangement, **eligible trainees** the Department will **pay the full student fee** to the provider on behalf of the trainee.
